GOVERNMENT AND PUBLIC AFFAIRS UPDATE

Fiscal Year 2013 Appropriations Deliberations Underway

On February 13, President Obama released his proposed Fiscal Year (FY) 2013 budget. Although many members of the House and Senate declared the budget “dead on arrival,” its unveiling marked an important first step in the annual appropriations process. The president’s proposal provides Congress with a baseline from which to consider its own numbers and policy recommendations for all federal agencies and programs.

At press time, the Commerce, Justice, Science appropriations act is the only FY 2013 funding bill important to the PAA that has been considered by both the House and Senate Appropriations Committee. Many Capitol Hill pundits agree that in light of election year politics, Congress is not likely to consider all of its appropriations bills prior to adjourning in September. Once again, this scenario increases the likelihood that a series of continuing resolutions will keep the government funded until Congress returns after the November election and passes an omnibus appropriations bill.

PAA belongs to a number of coalitions that reacted to the President’s budget. In sum, all of the coalitions that PAA belongs to endorsed the President’s request with the exception of the Ad Hoc Group for Medical Research, which advocates on behalf of funding for the National Institutes of Health (NIH). The Ad Hoc Group for Medical Research endorsed providing the NIH with \$2 billion more than requested by the Administration, which would bring NIH to \$32 billion in FY 2013—an amount reflecting inflation and modest room for growth. U.S. House of Representatives Votes to Eliminate the ACS

On May 10, the U.S. House of Representatives passed a bill, H.R. 5326, to fund the Census Bureau and other federal agencies in FY 2013. During the debate, Congressman Webster (R-FL) offered an amendment to ELIMINATE funding for the American Community Survey (ACS). The House passed the Webster amendment by a vote of 232-190. In addition, the House accepted an amendment by voice vote offered by Congressman Lankford (R-OK), making participation in the ACS voluntary.

In response to this action, PAA joined over 500 national, state, and local organizations, including the U.S. Conference of Mayors, International Council of Shopping Centers, and National Education Association, in signing a letter to the U.S. Senate, expressing alarm about the House actions and urging that chamber to support the ACS when it considers S.2323, its version of the Fiscal Year 2013 Commerce, Justice, Science appropriations bill. PAA has issued several related action alerts on this issue and is participating in meetings with key members of the House and Senate to help ensure the final funding bill does not include these ACS-related provisions.

Agency News

NICHD Reorganization Proceeds—As part of its ongoing Scientific Vision initiative, the new Director of the National Institute of Child Health and Human Development (NICHD), Dr. Alan Guttmacher, launched an effort to reorganize NICHD. A formal draft proposal was unveiled at the NICHD Advisory Council meeting on January 26, 2012. Of interest to the PAA and APC is the proposed renaming of the Demographic and Behavioral Sciences Branch (DBSB). The latest version of the reorganization proposal recommends renaming the branch, the “Population Dynamics” branch. Deliberations are still ongoing, and the complete reorganization will not go into effect until FY 2013.

Dr. Groves Announces Resignation—On April 10, 2012, Census Bureau Director Dr. Robert Groves announced that he will be leaving the Census Bureau in August 2012 to become provost of Georgetown University.

National Children’s Study—In the Administration’s FY 2013 budget, the NIH announced potential dramatic changes to the National Children’s Study (NCS). Specifically, the agency announced that because the study’s recruitment goals had fallen short and because cost containment remains a priority, NCS would move from a geographically-based to a provider-based recruitment strategy and abandon a national probability sample.

PAA and APC responded to this news with a letter to NCS Director, Dr. Steve Hirschfeld, NICHD Director, Dr. Alan Guttmacher, and NIH Director, Dr. Francis Collins, urging the agency to consider input from “experts in probability sampling” and to conduct research to evaluate the “feasibility and scientific value” of any new sampling strategy. In his response, Dr. Hirschfeld invited PAA and APC to make a statement at the NCS Advisory Committee on April 24. Incoming PAA President Dr. Christine Bachrach made a statement. On May 30, a delegation of PAA/APC officials, Dr. Dan Lichter, Dr. James Walker, Dr. Andrew Cherlin, Dr. William Axinn, and Dr. Sara McLanahan, met with Dr. Hirschfeld to discuss options NCS staff may consider to retain a national probability sample. The group will meet again via conference call before a final revised sampling approach is adopted.

Legislative Update

H.R. 931, a bill to make participation in the ACS voluntary—On March 6, 2012, the House Oversight and Government Reform Committee’s Subcommittee on Health Care, District of Columbia, Census and National Archives, held a hearing to discuss issues related to making participation in the American Community Survey (ACS) voluntary.

The focus of the hearing was a bill introduced last March by Congressman Ted Poe (R-TX), H.R. 391, which would make ACS participation voluntary and require individuals to answer only four questions on the ACS. Dr. Groves and three individuals representing the National Association of Realtors, U.S. Chamber of Commerce, and American Enterprise Institute all testified in support of the current mandatory ACS participation requirement. However, subcommittee chairman Congressman Trey Gowdy (R-SC) questioned the constitutionality of the ACS rather than its value as a source of data. H.R. 931 currently has 65 co-sponsors in the U.S. House of Representatives and could be marked up or considered by the Oversight and Government Reform Committee at any time in this session of Congress.

PAA and APC signed a letter organized by the Census Project coalition prior to the hearing, expressing support for keeping ACS participation mandatory. The letter is posted at: http://www.populationassociation.org/wpcontent/uploads/Census_Project_voluntary_ACS_letter.pdf.

In May, Senator Rand Paul (R-KY) introduced a companion bill, S. 3079. It was referred to the Senate Homeland Security and Governmental Affairs Committee for further consideration.

H.R. 3475, Keeping IDs Safe Act—On February 24, PAA Director of Government and Public Affairs, Mary Jo Hoeksema, organized a meeting with the majority staff of the House Ways and Means Committee, Subcommittee on Social Security. The purpose of our meeting was to discuss how the behavioral and social science research community use and protect data they obtain from the Social Security Death Master File (DMF). The meeting participants asked if federally-sponsored research, supported by the NIH and NSF for example, would qualify for an exemption stated in H.R. 3475, introduced by the subcommittee chairman, Congressman Sam Johnson (R-TX), for statistical and research activities conducted by federal and state agencies. The meeting participants also discussed the challenges researchers face if forced to use the National Death Index data rather than the DMF data. H.R. 3475 is still awaiting further action by the House Ways and Means Committee.

PAA in Washington, DC

PAA/APC Advocacy Days in D.C.—On March 26 and 27, select PAA and APC members conducted an impressive 45 meetings on Capitol Hill and at OMB and NSF to educate policymakers and staff on the population sciences and seek support for federal funding agencies. Some of our priority issues included expressing support for the NIH, Census Bureau, NSF, and NCHS, expressing concern about efforts to make participation in the ACS voluntary, and urging Congress to restore funding for the National Longitudinal Studies program in FY 2013.

Webinars

Balancing Employment with Family Care—On December 13, 2011, PAA, in cooperation with AARP and the Russell Sage Foundation, hosted their first webinar, “The Implications of Changing Workplaces and Families.” National experts Jennifer Cheeseman Day (U.S. Census Bureau) Nancy Folbre (University of Massachusetts), and Douglas Wolf (Syracuse University) discussed how the U.S. workforce and family have changed in recent decades and how these changes are affecting the ability of workers to manage career and family care responsibilities for children and aging relatives. Following the webinar, PAA posted a fact sheet, summarizing the major points raised by the speakers.

New Supplemental Poverty Measure—On April 19, 2012, PAA and APC sponsored: “How Are Children Faring? What the New Supplemental Poverty Measure Tells Us.” National experts David S. Johnson (U.S. Census Bureau), Timothy Smeeding (University of Wisconsin-Madison), and Jane Waldfogel (Columbia University) compared the Supplemental Poverty Measure (SPM) and the official poverty measure, showed what these measures reveal about poor children, and explained how the SPM can help policymakers and researchers better evaluate the impact of federal programs and policies designed to reduce poverty.

PAA/AAAS Science and Technology Fellowship

In June, the PAA/ AAAS (American Association for the Advancement of Science) Fellowship Committee announced the selection of its first Fellow, Dr. Tia Zeno, Johns Hopkins University. During her year-long fellowship, Dr. Zeno will be working in the NIH Office of Behavioral and Social Science Research, developing and evaluating programs and learning how the Office promotes behavioral and social sciences across the NIH Institutes and Centers. On September 1, 2012, PAA will begin accepting applications for the 2013-2014 fellowship. The announcement will be promoted on the PAA home page.

The Division on Behavioral and Social Sciences and Education (DBASSE) focuses the knowledge, analytical tools, and methods of the behavioral and social sciences on some of the nation's most pressing issues in efforts to understand them and to contribute to their solution. A large fraction of the work involves the design and execution of interdisciplinary advisory committees designed to generate reports that bring the knowledge and methods of the population sciences to bear on major issues of science and public policy.

QUALIFICATIONS: PhD in a related field or equivalent knowledge with 10 years of related professional experience, 5 of which were in a supervisory capacity.

The Director will need to have a keen interest in and broad knowledge of domestic and international population issues and substantial experience working at the intersection of research, policy, and practice. A doctorate in demography, sociology, or a related social science and at least ten years of related professional experience are required, as are demonstrated superior talents, skills, and abilities in networking and relationship building, project development, fundraising, communications, and project management and leadership. Excellent oral and written communication skills are essential.

Travel Awards for the 2013 Population Association of America Annual Meeting

With support from the Bill and Melinda Gates Foundation, the William and Flora Hewlett Foundation, and the PAA Fund, PAA will award travel grants to scholars from countries in the developing world (Africa, Asia, Latin America, Middle East) or Eastern Europe to attend the Annual Meeting in New Orleans, Louisiana, April 11-13. These grants cover the costs of round-trip transportation (including a possible stopover at a population research or training institution in North America in order to facilitate new or ongoing international collaboration), hotel and food expenses during the PAA meetings, membership and registration fees.

Eligibility criteria are: resident of a country in these regions; not currently receiving an international salary; not currently enrolled in Western graduate degree program; and did not receive a PAA travel award in the previous two years. In selecting recipients, priority will be given to applicants who appear on the meeting program, with highest priority going to sole or first authors of papers. Applications from African scholars are especially encouraged.

The deadline for submitting a paper or abstract for presentation at the meeting is September 21, 2012, and **the deadline for applying for a travel award is December 3, 2012. PAA Member Robert Moffitt named to the American Academy of Arts and Sciences

PAA Member Robert Moffitt was elected to the American Academy of Arts and Sciences on April 17, 2012, and will be inducted on October 6, 2012, in Cambridge, Massachusetts.

Moffitt is an authority on the incentives and disincentives inherent in the United States welfare system. Much of his research in labor economics has concerned the labor supply decisions of female heads of family and the effect their choices have on the welfare system. His research has led to publications about the Aid to Families with Dependent Children, Food Stamp, and Medicaid programs. He has published research on the labor supply effects of social insurance programs, including Social Security, unemployment insurance, and disability insurance, as well as the U.S.

income tax system. Moffitt has also studied the pattern of real wages over the business cycle and volatility in the U.S. labor market, as well as trends in U.S. earnings inequality, labor mobility, and state government decision-making. His research also focuses on population economics and economic demography, an area in which he has estimated economic models of marriage, cohabitation, female headship and fertility. Moffitt joined the Johns Hopkins faculty in 1995, and he holds a joint appointment at the university's Bloomberg School of Public Health. He is a past chief editor of the American Economic Review, a fellow of the Econometric Society and the Society of Labor Economists, and a National Associate of the National Academy of Sciences. Moffitt received a MERIT Award from the National Institutes of Health and a Guggenheim Fellowship, is a past vice president of the Population Association of America and served as chair of the National Academy of Sciences Panel to Evaluate Welfare Reform.

OBITUARIES

Frederic C. Shorter

Frederic C. Shorter passed away on Tuesday, February 22, at his home. He was 88.

Fred graduated from Reed College in 1944 and received his PhD in economics from Stanford University in 1957. He held positions at Princeton University's Department of Economics and Office of Population Research, in Turkey at Hacettepe University, and in Bangladesh (then East Pakistan) at the Planning Board, before joining the Population Council in 1973.

Fred worked for the Population Council for 22 years. His first assignment was as deputy director of the Council's Demographic Division. In 1976, Fred left New York to lead the Council's West Asia/North Africa (WANA) regional office in Cairo, where he played a major role in shaping and implementing Population Council activities throughout the WANA region.

After leaving the Council, Fred lived and worked in Turkey. In 1992, he received an honorary doctoral degree from the University of Istanbul Faculty of Medicine in recognition of his long and distinguished career of service to the health sciences in Turkey.

Fred's legacy lives on not only in the work of the individual scholars he supported through the Population Council's research awards program, but also in the collaborative relationships he established with research institutions throughout West Asia and North Africa. Those who knew Fred fondly remember his analytical skills, his supportive personality, and his deep commitment to the population research and his colleagues around the world. Paul Demeny, who first hired Fred to join the Council, remembers him as a cheerful, dynamic, and hardworking friend, whose optimistic outlook on life was one that very few people can match. Fred's wife, Zeyno Shorter, said that he kept his smile and optimism to the end.
